- Represented an industrial investment institution with over 40 billion RMB in investment scale in handling a dispute over a difference compensation agreement with the actual controller of a top domestic entertainment industry group at the Beijing Arbitration Commission. The case involved approximately 450 million RMB. Ultimately, successfully achieved a complete victory for the client.
- Represented a major domestic financial and real estate investment company in handling a lease contract dispute with a holding subsidiary of China's largest state-owned oil and gas enterprise at the Third Intermediate People's Court of Beijing Municipality. The subject matter was valued at over RMB 360 million.
